



**Proposed 28<sup>th</sup> Amendment to the Constitution of the United States:**

--- AJ Ensor

1. ***The 22nd amendment is repealed:*** Individual(s) elected to the United States Presidency, the Congress, and or appointed to the Judiciary Courts of Appeal including the Supreme Court; and or, any combination of service years therein, excluding military or civil service; shall not serve as a member of the Federal Government for a period of more than 12 years in total combination(s) of said offices, and except in time of war or national emergency; no person shall remain in service to the Federal, State or Local Government(s), in any office, elected or appointed, including the Judiciary, beyond seventy-five-years of age; and a person having served as President is disqualified from service as Vice-President [***12 years maximum service time for any one individual*** ]
  
2. In resolution of disputes or to advance the best interests of the nation; at least ninety-days before any federal election cycle; except when needed to resolve a crisis; The President as Chief Executive and Head of State shall order into the balloting process in all states and territories; a national referendum on any issue arising at law, public policy, at Presidential discretion, and to cite for contempt, jail and or fine, issue a warrant for, and or, remove permanently from any level of government; local, state, or federal; any elected official or member of the judiciary, agent or actor who attempts to obstruct or otherwise interfere with the referendum process, and may option do so with prejudice; baring that individual(s) in perpetuity from holding or seeking elected office or employment with any government entity, actor, grant receiver, agency, contractor or lobbyist, and, when any obstruction is successful the President may set a time and date of a re-vote at the State(s)' expense. [***The President may resolve any issue by putting it to a national vote***]
  
3. A Federal Referendum is conducted within the federal district(s) of each state. A Referendum that fails to obtain at least one half of votes cast in an election cycle shall not pass in that individual district. A referendum passes at or above the fifty-percent mark of votes cast in favor and, once half of the federal district(s) in any state have passed a referendum the state has adopted the referendum, and the ballot has won the state. [***American Democracy occurs within the states***]
  
4. Three-quarters of the states in the United States are required to vote in favor of, and or, adopt any referendum that is intended to amend the Constitution of the United States, and in all other cases or issue(s) arising at law a referendum is the rule of law within the venue of this Constitution whenever at least half the United States have adopted it. [***the states decide national policy as a group***]
  
5. An adopted referendum is the final arbitration of law within the venue of this Constitution; is not subject to judicial review; overrides all laws and judicial review that came before except for the four corners and plain English of the this Constitution as was established on the day the 14<sup>th</sup> Amendment herein was adopted or made exception to by amendments passed thereafter; without any and all other possible exception(s) arising at law until repealed or amended, and, the amendment or repealed of said law(s) can only be made exception to or rescinded by a new referendum process. [***the people say what the law is not Congress and not the Judiciary***]
  
6. Within the first fifty years of adoption: Any repeal or amending process, the population of voters seeking to repeal or amend an adopted referendum, now law, in each State, must be equal to and or higher than seventy percent of the population that originally adopted the referendum as law. Thereafter it will be fifty-one percent.
  
7. Qualified individuals who seek election to Congress may only establish funding for election processing from their own personal assets, spouse, parents or children not adopted, and or, any real person, including loans; excluding incorporation(s), charity or group organization(s); and said real person(s) to provide qualified donation(s) of not more than twenty-thousand-dollars in any period January through December (annually) to a congressional campaign must have established their residency and hold lawful domicile in the targeted Federal District(s) where polling is to be held at least nine months prior, and who are lawfully qualified to register to vote within said district(s); and within 21 days of any election day, only a candidate for office is qualified to authorize any expenses and pay any type of exchange of consideration for expenses including the advertising of their election process and all other individual(s) or entity(s) or group(s) without exception are prohibited; promotion(s) and advertising may only target the district(s) a candidate is

qualified to represent, and no state shall impose a fee(s) of more than one-thousand dollars upon any qualified candidate engaged-in election processing to any federal office; and election results shall be held secret, free of public commentary from any source in the use of the electromagnetic spectrum, by closed or open circuit, internet or broadcast the government shall block and criminalize said conduct and President may cite for election contempt, issue a warrant or restraining order for, fine and jail to enforce said standard from 12:01am until 11:59pm eastern United States Capital City Time of the election balloting day, and this one day only provision, nor the provision(s) stated herein whose purpose is to limited campaign financing; shall not abridge any freedoms otherwise guaranteed by this Constitution. The amount of allowable annual donation(s) to individual political campaigns may be expanded or reduced by a national referendum. **[there is no reporting election details on election day]**

8. The First Amendment to this Constitution is amended and a right of privacy is established to all citizens of the United States; excluding corporations; including electronic data gathering, sale or distribution of personal statistics by non-government actors including prohibiting government supervision and monitoring of personal banking, investment and currency and all exchange of consideration for commerce within the jurisdiction of this constitution shall be in American Currency only, and the equal protections of law apply to all real person(s) without exception, cannot be waved except in time of war or national emergency, and with no consideration to public notoriety, where all person(s) own their own image exclusively and removes from a free press any assertion of absent malice with regard to distribution of information that is not accurate, establishes full liability(s) and equal protection in all matters arising at law; for all individuals who suffered through the unlawful conduct by members of the press, and removes corporate veil protection(s) for individual actors, management and their decision(s) that violate privacy, and, in any contested issue, any retraction by the press must be timely and have the same headline, placement and audience reach to be established and admissible as a mitigating factor arising at law. **[government and media must stay out of people's private lives]**

9. Except as otherwise agreed to by the President and Chief Executive, Congress shall be in recess from the second Monday of December to the second day of January and from the second Monday of August until the second Monday of September and only the President possesses authority to appoint an individual to exercise the authority of administration and the President's authority to exercise an item-per-item, issue-per-issue, Aline-Item-Veto is incorporated herein without exception, and, any relief thereof rest exclusively with the Senate as previously assigned by this Constitution and is not subject to judicial review, and the chain of command for all administration and public policy begins with the president and all individuals who carry out the administration of government are subordinate.

10. At any level of government, individual(s) arrested or charged with a felony and whose conduct is reasonable judged to be a public threat, or is a risk of flight from justice, including any international actor, and or anyone person(s) charged in the unlaw distribution of controlled substance(s) such as drug(s); do not qualify for bail; and for those person(s) who remain in pre-trial incarceration, a "Quick and Speedy Criminal Trial" is not more than 120 days before a jury of 12 who are unanimous in their verdict, excluding military commission(s); and evidence presented to a grand jury for indictment must be equal to the required evidence need for conviction of beyond a reasonable doubt; in any failure of this standard the Judiciary or President may vacate the indictment to any level of government within the venue of this Constitution; and when any alleged expert gives testimony, that expert witness, maybe challenged before a jury at trial as to the quality and veracity of their expertise and any matter arising from science and research can only be presented by a witness certifiably and formally educated in said areas; and the Equal Application of the law(s) shall be guaranteed without exception to all person(s) whose presence within the venue of the United States is lawful, and the State(s) shall make no exception(s) or create alternative categories of law which have the effect of creating exception(s) to the penal code(s) and or reassign the process of investigation and enforcement away from law enforcement agent(s) and agencies and any citizen has a reasonable expectation that law enforce will investigate complaints of penal code violation(s), and no corporate veil shall hold individuals free from criminal liability; and any violation of law is a moment in time and only those law(s), rule(s), regulation(s) in that time moment are enforceable; any change in government law, rules or regulation(s) which alters potential outcomes or creates liabilities from the past that would not otherwise exists but for that change is ex post factor and prohibited. **[this corrects the abuse of the criminal and judicial processes within government]**
